

## PARENT/GUARDIAN SIGNING ON BEHALF OF A MINOR - RELEASE OF LIABILITY FOR PARTICIPANTS

## (PLEASE READ CAREFULLY BEFORE SIGNING)

I, the Parent/Guardian of the above named student, hereby acknowledge that I freely and voluntarily permit my child to participate in the 2022 Missouri Hugh O'Brian Youth Leadership Seminar to be held during the time period June 9th, 2023, through June 11th, 2023 (the "Seminar").

In consideration for HOBY's arranging this opportunity for my child to participate in the Seminar and enhancing my child's educational and leadership experience, I have fully read this Release of Liability ("Release") and hereby execute this Release with the intent to bind myself, my spouse (if applicable), my heirs, assigns, and legal representatives. I further represent that I am at least eighteen (18) years of age and competent to sign this affirmation and release.

I acknowledge that there is an element of risk involved in any activity involving travel outside of one's own home or community. I also fully understand and acknowledge that certain elements of the Seminar may be physically and emotionally demanding and that by my child's participation in the Seminar, my child faces risks of accidental and/or other physical and/or emotional injuries.

I understand and voluntarily choose to allow my child to assume the risk of participation in the Seminar. My child and/or I agree to advise the Supervisor at any point when my child is unsure about the ability to participate in any activity of the Seminar.

I authorize HOBY or any of its agents to provide, obtain, or authorize any incidental and/or emergency medical treatment for the Participant, in the event of the Participant's illness, injury, or incapacity, and hereby accept the responsibility to pay for such treatment.

I expressly agree and intend that my child's participation in the seminar shall be undertaken by my child at their own risk and that neither HOBY, its trustees, officers, employees, students, agents, volunteers, nor assigns shall be liable for any injuries, damages, claims, demands, actions or causes of action whatsoever which may arise out of or in connection with my child's participation in the seminar, whether from acts of active or passive negligence on the part of my child and/or on the part of HOBY, its trustees, officers, employees, students, agents, volunteers, or assigns, and I, for myself, my heirs, personal representatives or assigns, do hereby forever release, discharge, indemnify, and hold harmless its trustees, officers, employees, agents, volunteers, and/or assigns for any claims,

## causes of actions, demands, expenses, judgments, fees and costs whatsoever arising from or in connection with my child's participation in the seminar.

The terms of this Release are to be governed by and construed under the laws of Missouri. In the event any term or provision of this Release is found to be unenforceable or void, in whole or in part, the term or provision concerned shall be construed as valid and enforceable to the maximum extent permitted by law, and the balance of this Release shall remain in full force and effect. I agree that the exclusive venue for any dispute involving this Release in any way shall be Missouri.

I expressly affirm that I intend for any use of a keypad, mouse or other device to sign my name below ("E-signature") to be the legal equivalent of a manual hand-written signature for purposes of validity, enforceability and admissibility. I agree that no additional authority or third-party verification is necessary to validate my E-Signature and the lack of such verification will not in any way affect the enforceability of my E-Signature as pertaining to this waiver and release of liability.
